I hereby make application for permit as above, and if same is granted, I agree to conform to all applicable Building Codes, Town of Braselton Ordinances and Resolutions, Subdivision Regulations and plans and/or specifications submitted. Any person, firm or corporation violating any of the applicable codes, ordinances, resolutions, or regulations shall be deemed guilty of a separate offense for each and every day or portion thereof during which any violation is committed, continued, or permitted, and upon conviction of any such violation such person shall be punishable by a fine, or by imprisonment, or by both. Any variation from the submitted information may violate existing Town of Braselton regulations which will cause this permit to become null and void. This permit is valid for a period of six months and shall expire by limitation and become null and void if the building or work authorized by this permit is not commenced within six months from the issue date, or if the building or work authorized by such permit is suspended or abandoned for a period of six months or more after the work has commenced.
