## **ADVERTISEMENT FOR BIDS**

## Sanitary Sewer Erosion Repairs and Riverstone Park Stormwater Improvements for the Town of Braselton, Georgia ITB 2020-06

Sealed bids will be received by the Town of Braselton, Georgia (OWNER), for furnishing all materials, labor, tools, equipment, and any other miscellaneous items necessary for the construction of Sanitary Sewer Erosion Repairs and Riverstone Park Stormwater Improvements in Braselton, Georgia.

Bids will be received at the Town of Braselton – Town Hall, P.O. Box 306, 4982 Highway 53, Braselton, Georgia 30517 until 10:00 a.m. on August 18, 2020. Any bid received after said time and date of bid opening will not be considered by OWNER. Bids will be publicly opened and read aloud at this time and location. All bids will be evaluated by OWNER and the project will be awarded, if it is awarded, within sixty (60) days of the bid opening. If a bidder is not selected within sixty (60) days of the bid opening, any bidder that is determined by the OWNER to be unlikely of being selected for contract award shall be released from their bid.

The award of this bid proposal, if awarded, shall be based on several criteria, including prices bid, experience in the work proposed, and references. Refer to Article 14 of Section 00100 for criteria and award method.

The Project consists of, but is not limited to the following major elements at 3 separate sites:

Mulberry River Erosion Repairs (Site 1 – Between SR 124 and Hwy 85)

Relocate and abandon a portion of an 8" Dia. forcemain along the banks of the Mulberry River with  $\pm -300$  L.F. of 8" C900 PVC pipe, 2-8" Inserta Valves, and additional appurtenances as required.

Mulberry River Erosion Repairs (Site 2 – Mulberry River Walk)

Excavate and lower 3-36" Dia. CMP culverts, extend the 3-36" Dia. CMP culverts approximately 12 L.F. each, backfill over culverts and new pipe extensions to reestablish the walking trail and side slopes, modify upstream channel to provide smooth transition into entrance of culverts, and additional appurtenances as required.

Riverstone Park Stormwater Improvements (6317 & 6321 Marcelina Court)

Remove existing 30" Dia. CMP pipe and extend pipe system with 107 L.F. 30" Dia. CMP pipe, new junction box, and headwall, excavate approximately 400 C.Y. dirt for floodplain compensation, and use the dirt to fill and reshape the rear yards of the 2 residences, remove and replace portions of existing 6' high board fence with gates, sod the yard areas for the 2 residences, and additional appurtenances as required.

Time of completion for all work associated with this project shall be sixty (60) consecutive calendar days from the date of a written "Notice to Proceed" from OWNER.

OWNER requires a bid bond\* or a certified cashier's check in the amount of five percent (5%) of the total bid to be enclosed with the bid at the time of bid opening. Cashier's check will be made payable to the Town of Braselton, Georgia.

The successful bidder will be required to furnish OWNER with Insurance, Workman's Compensation Insurance, and Performance and Payment Bonds\* in the amount of one-hundred percent (100%) of the total bid.

Each bid must be submitted in a SEALED ENVELOPE, addressed to the OWNER. Each sealed envelope containing a Bid must be plainly marked on the outside as, "Sanitary Sewer Erosion Repairs and Riverstone Park Stormwater Improvements for the Town of Braselton, Georgia". If bid is forwarded by mail, the sealed envelope containing the Bid must be enclosed in a separate mailing envelope to the attention of the OWNER at the address previously given.

All Bids must be made out on the bid form of the type bound in the Contract Documents, in accordance with the instructions in the Information for Bidders. No interlineation, additions, or deletions shall be made in the proposal form by the BIDDER.

Any and all Bids received without the aforementioned qualification criteria enclosed, will be returned to the BIDDER.

CONTRACTORS and SUBCONTRACTORS bidding on this Project will be required to comply with all Federal, State, and local laws.

OWNER reserves the right to waive any informalities or to reject any or all Bids, to evaluate Bids, and to accept any Bid which in its opinion may be in the best interest of the OWNER. No Bid will be rejected without just cause.

Successful Bidder will be required to perform WORK as the Prime Contractor. WORK performed by Prime Contractor shall be at a minimum 30% of the contract value.

No BIDDER may withdraw his bid within the time limit specified in the Instruction to Bidders (Section 00100).

The OWNER has acquired all necessary State and Federal permits in connection with this project. The OWNER has acquired 60% of the easements and rights of way in connection with this project and anticipates that all such easements and rights of way will be acquired within 30 days of the date of receiving bids.

\* Surety and insurance companies must have an AM Best rating of A-6 or greater, be listed in the Federal Registry of Companies holding Certificates of Authority and Acceptable Sureties on Federal Bonds, be licensed by the Georgia Insurance Department and the Georgia Secretary of State to do business in the State of Georgia. Surety companies executing Bonds must appear on the Treasury Department's most current list (Circular 570 as amended) For Performance Bonds less than \$300,000 an irrevocable Letter of Credit from a bank as defined in O.C.G.A. Code Section 7-1-4 may be submitted in lieu of a bond. In lieu of a Payment Bond, a Cashier's Check, Certified Check, or Cash may be submitted in an amount not less than the total amount payable by the terms of the CONTRACT.
