Council Meeting Minutes  
January 13, 2020

The Town of Braselton met for its regular meeting on Monday, January 13, 2020.

Mayor Bill Orr called the meeting to order at 7:00 p.m.

Council members present were Becky Richardson, Peggy Slappey, Hardy Johnson and James Joedecke.

Mayor Orr led those in attendance in the Pledge of Allegiance.

Mayor Orr recited a tribute to Pam Braselton Jackson and asked for a moment of silence.

Councilmember Slappey made a motion to approve the minutes of the meetings from December 9 and 18, 2019. Councilmember Johnson seconded the motion, which passed unanimously.

Tony Falletta spoke during Citizen Comments.

Councilmember Joedecke made a motion to deny Application #19-06-CU. Councilmember Johnson seconded the motion, which passed unanimously.

Councilmember Joedecke made a motion to deny Application 19-07-RZ. Mayor Orr seconded the motion, which failed 2-3, Councilmembers Johnson, Richardson and Slappey voting against the motion.

Councilmember Johnson made a motion to approve Application 19-07-RZ with the recommendations of the planning Commission and the developer proposed conditions regarding requests from Gwinnett DOT, abandoning the access easement and building a fence. Councilmember Richardson seconded the motion, which failed 2-3, Mayor Orr and Councilmembers Joedecke and Slappey voting against the motion.

Councilmember Slappey made a motion to defer a vote on Application 19-07-RZ to the February Council meeting. The motion failed for lack of a second.

Councilmember Richardson made a motion to approve the resolution to request Braselton Parkway be added to the town speed detection permit. Councilmember Johnson seconded the motion, which passed unanimously.

Councilmember Slappey made a motion to approve the requests to scrap vehicles. Councilmember Richardson seconded the motion, which passed unanimously.
