The Town of Braselton met for its regular meeting on Monday, October 14, 2019.

Mayor Bill Orr called the meeting to order at 7:00 p.m.

Mayor Orr led those in attendance in the Pledge of Allegiance.

Councilmember Richardson made a motion to approve the minutes of the meeting from September 9, 2019. Councilmember Johnson seconded the motion, which passed unanimously.

There were no Citizen Comments.

A public hearing was held on the amendment to the Braselton Urban Redevelopment Plan. No one spoke.
