Council Meeting Minutes  
September 14, 2020

The Town of Braselton met for its regular meeting on Monday, September 14, 2020.

Mayor Pro Tem Peggy Slappey called the meeting to order at 7:00 p.m.

Council members present were Becky Richardson, Hardy Johnson and James Joedecke. Mayor Bill Orr was attending on the phone.

Councilmember Johnson made a motion to approve the minutes of the meeting from August 10, 2020. Councilmember Richardson seconded the motion, which passed unanimously.

There were no Citizen Comments

Councilmember Richardson made a motion to approve Application # 20-02-RZ with the conditions recommended by the planning Commission. Councilmember Johnson seconded the motion, which passed unanimously.

Councilmember Johnson made a motion to approve the Town initiated Planned Unit Development re-zoning and a Planned Unit Development Master Plan Amendment for property owned by Fountainhead Residential Dev. Corp. Inc. along with property previously annexed consisting of 30.69 acres in unincorporated Gwinnett County presently zoned RA 200 with the conditions as set by Council at their March 9, 2020 Council meeting which are incorporated by reference. Councilmember Slappey seconded the motion, which passed 4-1, Councilmember Joedecke voting against the motion.

Councilmember Johnson made a motion to approve the transmittal resolution for the STWP and CIE to be sent to the Regional Commission and Georgia DCA. Councilmember Richardson seconded the motion, which passed unanimously.

Councilmember Richardson made a motion to approve the Special Event permit for Elements for October 8th. Councilmember Slappey seconded the motion, which passed unanimously.
