**NOTICE OF

The Town of Braselton is soliciting applications from Contractors for pre-qualification to furnish labor, materials and equipment for MULBERRY RIVER STREAM RESTORATION PROJECT in the Town of Braselton.

Special Conditions: The Town of Braselton shall comply with O.C.G.A § 36-91-20, as amended, for **mandatory pre-qualification** of prospective bidders. Therefore, interested applicants should obtain a Pre-Qualification Application from the Town of Braselton, 4986 Highway 53, P.O. Box 306, Braselton, Georgia 30517. Applications will be evaluated based on established criteria listed in this application. All qualified and disqualified applicants will be notified in writing. Contractors will be considered "pre-qualified" upon issuance of the Notification of Pre-Qualification. Contractors under consideration for pre-qualification may NOT submit bids for projects that have advertised prior to the contractor's receipt of a notice of pre-qualification. Pre-qualification applications are due on August 20, 2021 by 4:00 PM.

Questions regarding pre-qualification applications should be directed to Sandy Weinel. Applications may be mailed to the Town of Braselton or submitted via email to Sandy Weinel. The review and approval process will require approximately three weeks from the date the application is received by the Town of Braselton. Any firm not pre-qualified may direct concerns to Sandy Weinel.

Applicant's qualification will be determined based upon the information presented. All questions must be answered in full, without exception. Failure to do so will result in the applicant being deemed nonresponsive, and the application returned to the applicant for completion; and applicant will not be considered for pre-qualification until such time as a complete application is submitted.

Although the Town of Braselton will take effort to notify pre-qualified Contractors of bids that are based on the established criteria of the application, it is ultimately the Contractor's responsibility to ensure that they remain abreast of Town of Braselton's solicitations. Projects advertised for bids may be reviewed on the Town's Website at [www.braselton.net/town\\_info/rfp\\_bids/index.php](http://www.braselton.net/town_info/rfp_bids/index.php) Depending on the scope and complexity of work to be performed, individual projects may require a project-specific pre-qualification, independent of the standard pre-qualification process.

- A. Applicant SHALL NOT attach information in lieu of completion of the application document. All information requested by the Town SHALL be provided within the application document; however, additional pages may be attached if more space is required (or if additional projects are necessary to demonstrate ability), or as otherwise instructed within the application document. All additional pages should be clearly labeled with the applicant's name, pre-qualification application title, and page number.
- B. If necessary, applicant should submit additional projects to prove all pre-qualification requirements are met.
- C. Reference projects must be complete prior to submittal of pre-qualification application.
- D. Applicant's qualification will be determined based upon the information presented. All questions must be answered in full, without exception. Failure to do so may result in the applicant being deemed non-responsive, and the application returned to the applicant for completion; and applicant will not be considered for pre-qualification until such time as a complete application is submitted.
- E. Only complete and accurate information shall be provided by the Applicant. The Applicant hereby warrants that, to the best of its knowledge and belief, the responses contained herein are true, accurate, and complete. The Applicant should complete the Applicant Certification included in this packet. The Applicant also acknowledges that the Owner is relying on the truth and accuracy of the responses contained herein. If it is later discovered that any material information provided by the Applicant given in response to a question, knowing it was false, shall constitute grounds for immediate disqualification and termination or rescission by the Owner of any subsequent agreement between the Owner and the Applicant. The Owner shall also have and retain any other remedies provided by law.

### III. MINIMUM QUALIFICATION CRITERIA

Contractors can submit and be qualified on all sub-sections, *or* specific sub-sections, which directly relate to their firm's experience only. Experience claimed for current personnel, while they were employed by another firm, WILL NOT be accepted. Please note that approval on limited sub-sections will restrict notification of projects to that type of work, only. The various sub-sections are as follows. Beginning on the following pages, list projects as noted below:

- 1) **Stream and Watershed Rehabilitation/Restoration**
  - PQ6 through PQ8
- 2) **Stormwater Best Management Practice Construction and Retrofit**
  - PQ9 through PQ11

Regarding Section IV Company Experience – Similar Projects, projects similar to the type of work to be performed **MUST** be submitted for review. Projects must meet all criteria stated below.

#### **Sub-Section 1) Stream and Watershed Rehabilitation/Restoration:**

The satisfactory completion of:

At least TWO (2) contracts **MUST** demonstrate rehabilitation/restoration of a perennial stream involving natural channel design and construction techniques (National Engineering Handbook Parts 653, 654. USDA, NRCS); including in-stream rock and/or log structures within the past FIVE (5) years where length of stream was 500 linear feet or more for EACH PROJECT. Installation **MUST** include aforementioned in-stream structures. Bank armoring or re-grading alone will not qualify.

#### **Sub-Section 2) Stormwater Best Management Practice Construction and Retrofit**

The satisfactory completion of:

At least TWO (2) contracts **MUST** demonstrate the satisfactory installation of at least one (1) green infrastructure/low impact development best management practice (bioretention basins/areas, bioslopes, filter strips, infiltrative swales, grass channels, regenerative stormwater conveyances) within the past FIVE (5) years. Facility **MUST** have been designed and constructed according to one of the following standards: *Georgia Stormwater Management Manual*, *Town of Braselton Stormwater Management Manual*, or equivalent state/local government plans and specifications (equivalents must be specified and the Town shall be the sole determinant of equivalent standards).
